

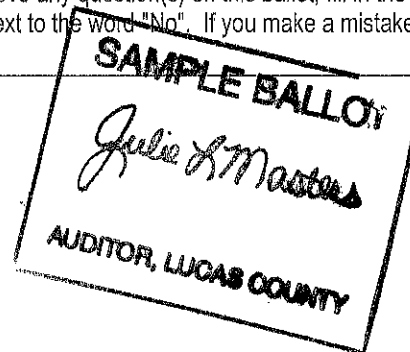

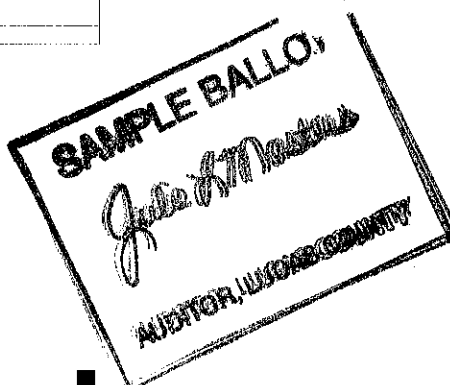

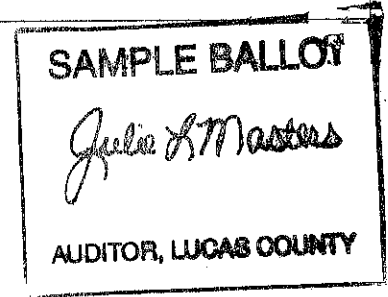

Public Measure NQ

Shall the following public measure be adopted?

Summary: To authorize a change in the allocation and use of the one percent (1%) local sales and services tax in the City of Russell, Iowa effective January 1, 2024.

The use of the one percent (1%) local sales and services tax shall be changed in the City of Russell, Iowa effective January 1, 2024.

Proposed uses of tax:

If the change is approved, revenues from the sales and services tax shall be allocated as follows:

- 0% for Property tax relief
- 60% for Road Use Fund
- 40% for General Fund for General Municipal Purposes
- 0% for operation and maintenance of municipal swimming pool

Current uses of tax:

Revenues from the sales and services tax are currently allocated as follows:

- 0% for Property Tax Relief
- 60% for Road Use Fund
- 30% for General Fund for General Municipal Purposes
- 10% for operation and maintenance of the municipal swimming pool
